Dear Participant: We are back once again and very excited to be hosting this amazing Preston City Community Event! Carefully read the details on vendor participation. **Space is limited.** "Brand" vendors (i.e. LuLa Roe, Tastefully Simple, Avon, etc.) will be accepted on a first come basis and at the discretion of the Scarecrow Festival Committee.

**Time:** Saturday, 10 am — 4 pm

**Set Up.** Friday from 4:30 pm — 6:30 pm **OR** Saturday 7:00 am — 9:00 am  
(Note: there will be Scouts staying Friday night to watch over festival grounds).  
**\*Your vehicle must be cleared of the display area by 9:30 am on Saturday.**  
There will be special vendor parking on Krug Road.

**Break Down:** Saturday from 4:00 pm — 4:30 pm  
Vendors must stay until the end of the festival or may be disqualified for future participation. Under NO circumstances will vehicles be allowed on Festival Grounds **PRIOR** to 4:00 pm

\$60 per 10'x10' space **OR** \$120 for a 10'x20' space

**Fees:**  
**\* Early Registration Discount: Deduct \$10 off single (\$20 off double) if application and fee received at the church before May 12, 2025**

This festival is "rain or shine." There are NO refunds due to the inclement weather. Per Fire Marshall, tent poles must be weighted down. Booth spaces cannot be reserved **and** there is no sharing of booths. NSF checks will be charged \$20. Any vendor selling packaged consumable goods (i.e., sauces, jerky, etc.) **must carry insurance.** A copy of insurance **must** be sent in with application.

**No** sales of alcohol, tobacco, marijuana, or vaping products. **No** knives, bong, lasers, guns, or any other items not mentioned herein which might be considered in violation of the laws and/or the rules and regulations of the U.S. Government, the State of Connecticut, New London County, the Town of Preston, PCCC Church, and the PCCC Scarecrow Festival Organizers.

**No** alcoholic beverages, smoking, or pets allowed in or around vendor tents/booths.

**Tables and chairs are not provided.**

Vendors are encouraged to participate in making a scarecrow and displaying it at your booth.

Attendees will judge the day of the Festival, and the winner of the Vendor category will receive a FREE 10x10 space next year! Participation also brings more attendees around to your booths.

Preston City Congregational Church's will have a variety of delicious food available for you to purchase this year.
